UPON hearing the counsel the Court made the following
O R D E R

1. NOIDA is directed to comply with the direction contained in paragraph 7(viii) of the order dated 16.12.2025, without prejudice to its claim *re:* the prescribed charges.
2. Meanwhile, the Court-appointed Committee will take a decision, in terms of the order dated 20.01.2026, with regard to the charges/claim raised by NOIDA, whereafter an appropriate order shall be passed by this Court upon hearing all the relevant stakeholders.
3. To await the report of the Court-appointed Committee, post the matter on 24.07.2026.
4. Meanwhile, counter affidavit, if any, shall be filed within three weeks.
5. Lastly, on oral mentioning, paragraph 5 of the order dated 30.04.2026 stands corrected and shall be read as follows:

“5. The forensic audit of Supertech Limited is directed to be commenced by M/s. Ernst & Young on the same terms and conditions as were finalised for SRPL earlier.”
